Wilson Early Childhood Center Parent and Family Engagement Policy/Plan and Procedures

Wilson Elementary is committed to the goal of providing quality education for every child in our school. To this end, we want to establish partnerships with parents and with the community. Everyone gains if Wilson and home work together to promote high achievement by our children. Neither home nor Wilson can do the job alone. Parents play an extremely important role as children's first teachers. Support for their children and for the school is critical to children's success at every step along the way.

Wilson recognizes that some students may need the extra assistance available through the Title I program to reach the state's high academic standards. Wilson intends to include parents in all aspects of the school's Title I program. The goal is a school-home partnership that will help all students succeed.

F. If the schoolwide program plan is not satisfactory to the parents of participating children, encourage parents to submit comments regarding the plan. Comments will be shared during next meeting and discussion will occur regarding possible revisions.

- -Conduct parent/teacher conferences at Wilson, a minimum of two per year, during which the compact shall be discussed as the compact relates to the individual child's achievement.

- 2. Provide materials and training to help parents to work with their children, such as literacy training and using technology as needed.
- 3. Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parent and their communities to increase academic achievement.
- 4. Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.

- 9. May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize Parent and Family Engagement and participation
- 10. May adopt and implement model approaches to improving Parent and Family Engagement.
- 11. May establish a district parent advisory council to provide advice on all matters related to Parent and Family Engagement in programs supported under this section.
- 12. May develop appropriate roles for community-based organizations and businesses in Parent and Family Engagement activities.
