

Miami Jr High School Parent and Family Engagement Policy/Plan and Procedures

MJHS is committed to the goal of providing quality education for every child in this district. To this end, we want to establish partnerships with parents and with the community. Everyone gains if MJHS and home work together to promote high achievement by our children. Neither home nor MJHS can do the job alone. Parents play an extremely important role as children's first teachers. Support for their children and for the school is critical to children's success at every step along the way.

MJHS recognizes that some students may need the extra assistance available through the Title I program to reach the state's high academic standards. MJHS intends to include parents in all aspects of the school's Title I program. The goal is a school-home partnership that will help all students succeed.

PART I-SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY/COMMITMENTS

- A. MJHS will jointly develop/revise with parents the school Parent and Family Engagement policy/procedures and distribute it to parents of participating children and make available the Parent and Family Engagement policy/procedures to the local community.

- 3. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as practically possible.
- F. If the schoolwide program plan is not satisfactory to the parents of participating children, encourage parents to submit comments regarding the plan. Comments will be shared during the next meeting and discussion will occur regarding possible revisions.

PART II-REQUIRED SHARED RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

As a component of the school-level Parent and Family Engagement policy, each school shall jointly develop with parents for all children served under this part, a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.

- -Conduct a parent/teacher conference in elementary schools, annually (at a minimum), during which the compact shall be discussed as the compact relates to the individual child's achievement.

To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, each school and district must:

- 1. Assist parents in understanding the challenging State academic standards, how to monitor a child's progress, and work with educators.
- 2. Provide materials and training to help parents to work with their children, such as literacy training and using technology as needed.
- 3. Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parents and their communities to increase academic achievement.
- 4. Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.
- 5. Ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand.

The following are allowable activities:

1. May involve parents in the development of training teachers, principals, and other educators to improve the effectiveness of such training.

- 2. May provide necessary literacy training from funds received under this part if the district has exhausted all other reasonably available sources of funding for such training.
- 3. May pay reasonable and necessary expenses associated with local Parent and Family Engagement activities, including transportation and childcare costs, to enable parents to participate in school-related meetings and training sessions.
- 4. May train parents to enhance the involvement of other parents.5
- 5. May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize Parent and Family Engagement and participation6
- 6. May adopt and implement model approaches to improving Parent and Family Engagement.
- 7. May establish a district parent advisory council to provide advice on all matters related to Parent and Family Engagement in programs supported under this section.
- 8. May develop appropriate roles for community-based organizations and businesses in Parent and Family Engagement activities.
