Nichols Parent and Family Engagement Policy/Plan and Procedures

Nichols is committed to the goal of providing quality education for every child in this district. To this end, we want to establish partnerships with parents and with the community. Everyone gains if Nichols and parents work together to promote high achievement by our children. Neither home nor Nichols can do the job alone. Parents play an extremely important role as children's first teachers. Support for their children and for the school is critical to children's success at every step along the way.

Nichols recognizes that some students may need the extra assistance available through the Title I program to reach the state's high academic standards. Nichols intends to include parents in all aspects of the school's Title I program. The goal is a school-home partnership that will help all students succeed.

- 9. May train parents to enhance the involvement of other parents.
- 10. May arrange school meetings at a variety of times or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize Parent and Family Engagement and participation
- 11. May adopt and implement model approaches to improving Parent and Family Engagement.
- 12. May establish a district parent advisory council to provide advice on all matters related to Parent and Family Engagement in programs supported under this section.
